Update on the 64th session of the HSC

Report by the secretariat.
Re-examination of the 'classification of a tobacco product called EHTP' –
requested by Saudi Arabia.
Re-examination of the classification of 'Qudra 440XL Chrome' tap serving instant
boiling and shilled filtered water – requested by the Philippines. – some parties
thought heating was important and other places they thought cooling was
important. However, the most important aspect was seen as the filtering aspect.
Re-examination of the classification of an emergency kit for motor vehicle –
requested by the Philippines – need to look at the essential character of the product
and they looked at GRI 3 c.

- Member economies have 2 months after meeting to file committee objection
- ICC send report of meeting outcome
- 158 parties signed HS Convention harmonised system made up of 5000 6 digit codes
- Govern how goods are classified in the system

For example: how should hybrids be defined? Running watch is an issue - some parties view anything on wrist as a watch VS others view anything with digital capability as not a watch (depending on how much communication and processing is required)

HS committee make decisions approved by Policy Commission

Future of the HSC:

- Will need to go to Policy Committee
- Position of ICC? Not most interesting topic but very important
- Could go directly to secretariat outside of the process
- International Customs Association involved
- Question on advanced rulings? Not sure how it will fit into HS reform

Main business – professional logistics, agency and related business and e-commerce
Urbanisation in south east Asia – cities are becoming denser in population, Last mile distribution
E-commerce in south east Asia is still at nascent stage which only less than 5% of total retail sales
South east Asia e-commerce will be worth USD 88 billion by 2025
Last mile delivery of goods involved several levels of complexity which include multiple stakeholders
Each stakeholder has diverging interests and objectives
Lack of communication results in no common shared priorities and aligned actions
The complexity often leads to inefficiency sub optimal or even non-productive solutions

Last mile delivery stakeholders:

- Environmental, economic, political interrelated but each have own objectives they don't share information
- This complexity often leads to inefficiency sub optimal or even productive solutions
- More Co2 and congestion is being created south east asia

Impact on Last mile Delivery

- Traffic worsens
- Pollution worsening
- More trucks on the road
- Higher energy consumption

Improvement on Last Mile Delivery

• Looking at reducing impact on urban logistics

Last Mile Strategies

- Urban Consolidation Centre: more efficient delivery of goods
- Off hour night distribution
- Pick up points (locker box) reduce wastage from attempted delivery
- Shared economy lesser transport vehicles
